Tournament Playing Rules

General Rules:

- (a) All games will be played under "WSYSA Rules of Competition" unless stated herein.
- (b) Game Sheets and Player Passes are mandatory.
- (c) Field and referee coordination is the responsibility of the hosting District/Association.
- (d) It shall be the responsibility of each team to maintain proper spectator conduct. Each coach, manager, club, Association, or District official shall be held primarily accountable for the conduct of spectators for or from their respective teams. At no time shall foul or abusive language be permitted at any field.
- (e) Each player shall have a number on the player's jersey. The number shall be affixed to the back of the jersey, clearly visible and a minimum of six (6) inches high. Each player on a team must wear a number different from the number of every other player on the team. Numbered jerseys for goalkeepers are optional.
- (f) Ties in the elimination rounds game play will be resolved as follows:
 - (2) U-11 Two up to a maximum 10 minute overtime periods
 - (3) If still tied, FIFA Kicks From The Mark procedures will be followed.

(overtime periods for SEMI final matches will be adjusted for available field time)
- (g) Uniform Color Conflict
The designated "home team" will be responsible for changing color of the team uniforms in the event of a color conflict and will have choice of sideline. The "home team" will be the team listed first on the schedule.
- (h) Violations and Penalties
Playing of a player not listed on the Recreational Cup Tournament Roster held by the Host Site Director shall result in forfeiture of any and all Recreational Cup games in which that player appeared on the roster presented to the referee. In addition, that team shall be suspended for the remainder of the Recreational Cup tournament.
Should a team be suspended from Recreational Cup competition, any remaining games scheduled for that team shall be recorded as a forfeit
